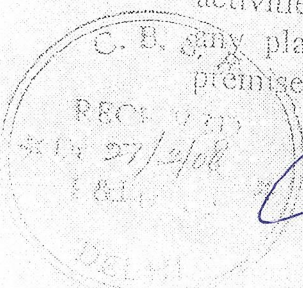

Subject: Grant of recognition (without aid) from Nursery To Class XII in Arts and Commerce w.e.f. 2008-09.

Sir/ Madam,

In continuation to this officer order No.47/DDE(East)/2006-07/173 dated 18/2/2008, wherein provisional recognition was granted to the school with the condition to submit the fire safety certificates issued by Chief Fire Officer, Delhi within three months. Since the school authority has submitted the copy of fire safety certificate issued by Chief Fire Officer dated 30/11/2005, the recognition is granted (without aid) from Nursery to class- XII in Arts and Commerce subject to the fulfillment of the following terms & conditions :-

1. That the school shall abide by the provisions of Delhi School Education Act, 1973 and Rules framed there under as well as the instruction issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school shall appoint full time & qualified staff for all students.
4. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ration of 10 books per students shall be purchased and made available to the students.
5. That adequate sports material shall be purchased and made available to the students.
6. That the school shall strictly abide by the provisions of section 10(1) of the Delhi School Education Act / Rules 1973.
7. That the school shall not run any un-recognized classes of any non-educational activities within the school premises and all the recognized classes shall be run at any place at the above address only. Nursery classes be removed from the premises of the School immediately, if any.

8. That the school shall dispense the services of unqualified and over-aged staff, if any immediately.
9. The Management of the school will obtain land from DDA, if already not obtained, in the name of the society through Director of Education, Delhi and shall construct a school building thereon for the school as per specification of the Department within the period of three years. That adequate and sufficient accommodation of Sq. Ft. per students shall be provided for classroom. The normal size of the classroom will be 15' X 20'
10. That proper facilities for drinking water, toilet and first - aid to be provided. Separate toilets for boys & girls and separate toilets for ladies and gents staff be also provided.
11. That the Managing Committee of the School shall not increase/ enhance fee during the ensuring academic session without prior approval of the Director of Education which is mandatory requirement under sub-session (3) of Section 17 of Delhi School Education Act and Rules 1973.
12. That all the facilities prescribed under rules 50 & 51 of DSER 1973 shall be made available to the students.
13. That the Management of the School shall create a Reserve Fund equal to minimum three months salary of est. staff in the joint name of Director of Education and Manager of the School.
14. That the school shall comply with the norms of the CBSE for affiliation fees/examination purpose.
15. The management of the school will ensure admission to the weaker section of the society as per prescribed norms of the Directorate of Education
16. If a fresh health certificate is required to be submitted from the school within a month.
