11. That the Managing Committee of the School shall not increase/ enhance fee during the ensuring academic session without prior approval of the Director of Education which is mandatory requirement under sub-session (3) of Section 17 of Delhi School Education Act and Rules 1973.

13. That the Management of the School shall create a Reserve Fund equal to minimum three months salary of eth staff in the joint name of Director of Education and Manager of the School
